

**SOUTH HADLEY ELECTRIC LIGHT DEPARTMENT
BOARD OF COMMISSIONERS EXECUTIVE SESSION HYBRID MEETING
TRUSTEES ROOM AT THE LIBRARY
MAY 22, 2025, AT 5:15 P.M.**

The open session of the hybrid meeting was called to order by Chair John Hine at 5:15 P.M. A motion was made to move into executive session for the purposes of discussing fiber projects and to discuss property and return to open session at approximately 6:00PM (see open session minutes for vote).

Fiber Financials: Mr. Fitzgerald stated that Mr. Conchieri would present 2024 Telecom Financials and recommended the continuance of treating Telcom financials as competitively sensitive, confidential, and trade secret protected information. SHELD has maintained Telecom financials in accordance with the 2023 ruling from the Secretary of State's office which ruled that MGL c. 164 §47D provides that they shall be exempt from the public record requirements of section 10 chapter 66, and that the Department has met its burden of proof that they meet the standard of trade secrets, confidential, competitively sensitive or proprietary information in accordance with Secretary of State December 2023 Public Records determination.


Mr. Fitzgerald reiterated that the Telecom business is a highly competitive business and it's in our best interest to keep our rates confidential so our competitors cannot underbid us for our current or future fiber business by having access to our fiber financials. MLPs that have fiber can keep their fiber financials private as detailed by the Secretary of State's determination with SHELD.

Mr. Conchieri presented the Board with revenue and expenses separately for electric, telecom, and the total for both for 2024. He also showed the fiber financials separately for each of the three towns. While the electric side of the business has a cap on profits each year, the telecom side does not have this restriction. Fiberspring showed a profit for 2024, but now that the South Hadley plant is five years old, it's time to upgrade older equipment that is approaching its end of life and to expand the XGPON platform to 2 gig to be able to increase bandwidth as our customer base continues to grow.

Mr. Hine asked if any Board members wanted to discuss or make a motion to no longer utilize Mass General Law to keep the fiber information private. No one motioned.

Building property update: Mr. Fitzgerald stated that the architect who designed the conceptual plans for the new building would attend open session to discuss the plans and that we would be releasing the property location to the public during open session.
