### Product Information

- Air Source Heat Pump - \$500 per 12,000 BTUs of Cooling Capacity
    - (SEER ≥ 16, HSPF ≥ 9) OR (SEER2 ≥ 15.3, HSPF2 ≥ 7.65)
  - Ground Source Heat Pump - \$750 per 12,000 BTUs of Cooling Capacity
    - (EER ≥ 20, COP ≥ 3.5) OR (EER2 ≥ 19.2, COP ≥ 3.5)
  - Maximum rebate amount is 36,000 BTUs per address, per calendar year\*
- Note: Exact rebate dollar amount is calculated using the Cooling Capacity BTUs listed on the AHRI Certificate*
