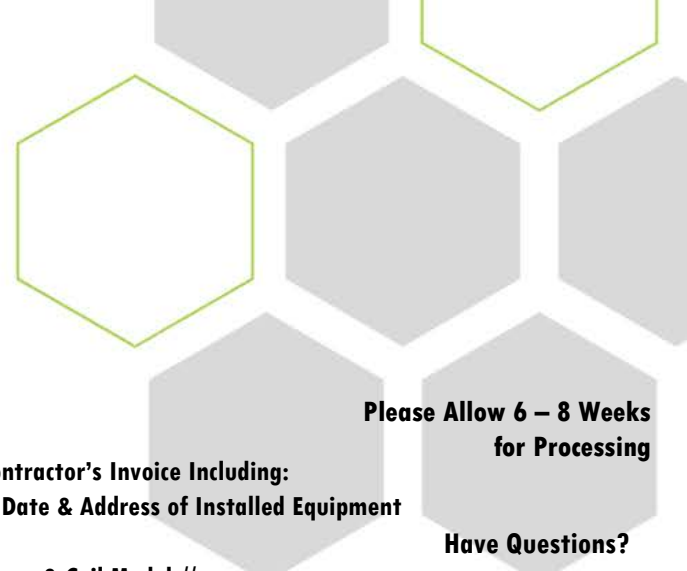

- Condenser & Coil Model #s
- Size in Tons
- Total Installation Cost
